AN ORDINANCE AMENDING SECTION 58 of ORDINANCE
NO. 1 RELATING TO SERVICE CHARGES


THE BOARD OF DIRECTORS of the ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT
does ordain as follows:


Section 1: Section 58 is hereby amended to read as follows: The
monthly service charge for each single family residence shall be \$3.20 per
month. The service charge for multiple dwellings shall be the base rate
of \$3.20 multiplied by the number of such groups of two or more persons,
cooking, eating and living together as a family and having separate toilet
and sink facilities. The monthly service charge for commercial establish-
ments with less than 25 fixture units shall be \$3.90 per each such separate
establishment, whether such establishment be housed separately or be a unit
of a building with multiple units, except that the service charge for public
houses serving more than 100 meals per day, or commercial establishments with
more than 25 fixture units shall be determined by the Board for each specific
application. The monthly service charge for trailers shall be \$2.70 per
month per trailer unit or space prepared for trailer occupancy. The service
charge for industrial processing plants discharging industrial wastes shall
be determined by the Board for each specific application.
