ORDINANCE NO. 98-01

AN ORDINANCE AMENDING SECTION 52
OF ORDINANCE NO. 96-2 RELATING TO
PARTICIPATION CHARGES AND SECTION 1
OF ORDINANCE NO. 97-01 RELATING TO
MONTHLY SERVICE CHARGES

BE IT ENACTED BY THE BOARD OF DIRECTORS OF SOUTH PLACER MUNICIPAL
UTILITY DISTRICT AS FOLLOWS:

Section 1

Section 52 of Ordinance No. 96-2 is hereby amended to read as
follows:

Section 52:

A basic participation charge for each equivalent dwelling
unit is hereby fixed and established as follows:

<u>Calendar Years</u>	<u>Local Charge</u>	<u>Regional Charge</u>
January, 1999 thru December, 2003	\$1,500.00	\$3,105.00 ¹

Section 2

Section 1 of Ordinance No. 97-1 is hereby amended to read as follows:

Section 1

A monthly service charge for each equivalent dwelling unit
is hereby fixed and established as follows:

<u>Fiscal Year</u>	<u>Monthly Charge</u>
1998/99	\$ 15.25
1999/00	\$ 15.50
2000/01	\$ 15.75
2001/02	\$ 16.00
2002/03	\$ 16.00

Section 3

Such monthly service charge and/or local share of the participation charge may be changed from time to time by ordinance.

Section 4

This Ordinance shall be effective retroactive to July 1, 1998.

Section 5

This Ordinance was introduced at an adjourned regular meeting of the Board of Directors held on the 18th day of June, 1998.

Section 6

Upon final passage, this Ordinance shall be published once a week for two successive weeks in a newspaper of general circulation within the District, pursuant to the provisions of Sections 11534 and 11910 of the Public Utilities code.

Board Members:

Pursuant to the provisions of Section 14401 of the Public Utilities Code and based on the Bartle Wells Associates report, South Placer M.U.D. Wastewater Financing Plan Update, dated June, 1998, it is my recommendation that the District's monthly service charge per EDU be fixed and established in accordance with the following schedule:

1999/00	\$ 15.50
2000/01	\$ 15.75
2001/02	\$ 16.00
2002/03	\$ 16.00

Also, Pursuant to provisions of Section 14401 of the Public Utilities Code, and Section 3d, 1 of the agreement dated June 17, 1981 between the District and the City of Roseville, and the Bartle Wells Associates report mentioned above, it is my recommendation the District's participation charge per EDU be fixed and established in accordance with the following schedule:
