

1 DETERMINING THAT THE ANNEXATION OF CERTAIN
2 UNINCORPORATED TERRITORY WILL FACILITATE THE
3 OPERATION OF A PUBLIC UTILITY BY THE ROCKLIN-
4 LOOMIS MUNICIPAL UTILITY DISTRICT AND BE OF
5 ADVANTAGE TO SAID DISTRICT, DETERMINING AND
6 SETTING FORTH THE TERMS AND CONDITIONS UPON
7 WHICH SAID TERRITORY MAY BE ANNEXED TO SAID
8 DISTRICT AND DECLARING THE INTENTION OF
9 CAUSING THE SAME TO BE APPROVED BY SAID
10 DISTRICT, AND GIVING NOTICE OF THE TIME
11 AND PLACE FIXED FOR HEARING THEREON

14 WHEREAS, a petition, addressed to the Board of Directors
15 of the Rocklin-Loomis Municipal Utility District describing cer-
16 tain unincorporated territory more particularly described herein-
17 after and requesting that proceedings be taken for its annexation
18 to said District has been filed with the Secretary of said Dis-
19 trict, and said Secretary has ascertained and determined that said
20 petition has been signed by or on behalf of all of the owners of
21 the real property described therein and duly verified by the
22 affidavit of one of the petitioners, and said Secretary has
23 attached his signature to said petition and presented the same to
24 said Board of Directors; and

25 WHEREAS, said Board of Directors has duly investigated
26 and considered the advisability of annexing said territory and
27 the terms and conditions upon which such annexation shall be made;

28 NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF DIRECTORS
29 OF THE ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT:

30 Section 1 That the annexation of that certain unincor-
31 porated territory more particularly described in Section 3 here-
32 after will facilitate the operation of a public utility by said
District and be of advantage to said District and that such terri-
tory should be annexed to said District upon the terms and condi-
tions hereinafter set forth in Section 2.

Section 2 That the terms and conditions for the annexation
of said unincorporated territory are found and determined by
said Board of Directors to be satisfactory and agreeable and said

1 Board of Directors does hereby declare its intention of causing
2 the same to be approved by said District. Said terms and condi-
3 tions are the provisions of that certain agreement by and between
4 the Rocklin-Loomis Municipal Utility District and Sunset Inter-
5 national Petroleum Corporation dated August 29, 1963, a copy
6 of which said agreement is attached hereto as Exhibit A and in-
7 corporated herein by reference as though set forth at length at
8 this place.

9 Section 3 The unincorporated territory to be annexed to
10 said District is all that real property lying in the County of
11 Placer, State of California, more particularly described in
12 Exhibit B attached hereto and incorporated herein by reference as
13 though set forth at length at this place.

14 Section 4 This ordinance, which contains the notice
15 fixing the time and place for hearing thereon, shall be published
16 once in the Loomis News, a newspaper of general
17 circulation published in said District, and such publication shall
18 constitute due notice of said hearing and no other notice need be
19 given.

20 Section 5 Notice of the hearing referred to in Section
21 4 is hereby given as follows:

22 NOTICE FIXING TIME AND PLACE FOR HEARING ON THE
23 QUESTION OF THE APPROVAL BY THE ROCKLIN-LOOMIS MUNICIPAL
24 UTILITY DISTRICT OF THE TERMS AND CONDITIONS FOR THE
25 ANNEKATION OF CERTAIN UNINCORPORATED TERRITORY.

26 NOTICE IS HEREBY GIVEN that the Board of Directors
27 of the ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT has
28 fixed Wednesday, the 9th day of October,
29 1963, at the hour of 8:00 P.M. of said day in the
30 office of the ROCKLIN-LOOMIS MUNICIPAL UTILITY DISTRICT,
31 Highway No. 40, Loomis, California, as the time and
32 place for hearing on the question of the approval by the

ROCKLIN-LOSMIS MUNICIPAL UTILITY DISTRICT of the terms and conditions set forth by reference in Section 2 of Ordinance No. 63-2 of the Board of Directors for the annexation of certain unincorporated territory in the County of Placer, State of California, more particularly described by reference in Section 3 of said Ordinance.

NOTICE IS FURTHER GIVEN that at the time and place fixed herein, or at such time and place to which such hearing may be adjourned, any person interested may file written objections to the approval of such terms and conditions with the Board of Directors of said District. Failure of any person interested in said District or in the matter of the proposed annexation on said terms and conditions, to show cause in writing as aforesaid shall constitute an assent on his part to a change in the boundaries of said District.

NOTICE IS FURTHER GIVEN that at the time and place fixed herein, or at such time and place to which such hearing may be adjourned the Board of Directors of said District shall determine whether or not said terms and conditions shall be approved and shall hear and determine all objections thereto.

Section 6 A copy of this Ordinance shall be filed with the Secretary of said District.

Section 7 This Ordinance shall take effect immediately.


